

### 1. The Promoter

The promoter is: MARRINGTON ESCAPES LIMITED (06796208) of WELSH BRIDGE, SHREWSBURY, SHROPSHIRE, SY3 8LH.

# 2. The competition

The title of the Competition is MARRINGTON ESCAPES GIVEAWAY.

### 3. How to enter

- 3.1 The Competition will run from 19:00 24 August (the "**Opening Date**") to 23:59 on 14<sup>th</sup> September 2022 (the "**Closing Date**") inclusive.
- 3.2 All competition entries must be received by the Promoter by no later than 23:59 on the Closing Date.

  All competition entries received after the Closing Date are automatically disqualified.
- 3.3 To enter the Competition on an entrant must:
- a) Like and save the post shared on the Instagram of @marringtonescapes from 24 August until 14 September which sets out in the post description that it is the competition post (the "Instagram Competition Post");
- b) Follow the Instagram account @marringtonescapes and;
- c) Tag another Instagram user in the comments of the Instagram Competition Post by @marringtonescapes.

## OR

- a) Like the post shared on the **Facebook** of @marringtonescapes from 24 August to 14 September which sets out in the post description that it is the competition post (the "Facebook Competition Post");
- b) Like AND follow the Facebook accounts at @marringtonescapes and;
- c) Tag another Facebook user in the comments of the Facebook Competition Post by @marringtonescapes

### 5. The prize
